WHEREAS, the Economic Development District was established by Jefferson Parish Ordinance No. 20369, (June 3, 1998) and by City of Gretna Ordinance No. 3528, (April 12, 2005). Boundaries: East side of Ocean Avenue from the river to the Fourth Street right-of-way; west side of Hancock Street; the Orleans Parish line; and the Mississippi River; and

WHEREAS, to further the redevelopment of the designated Economic Development District within the City of Gretna, it is necessary and appropriate to provide incentives for development; and

WHEREAS, the property for James Rolf, located at 1320 Monroe Street (Assessment No. 0100002702), City of Gretna, Louisiana, Project No. 20230405, within a designated Economic Development District, Jefferson Parish, Louisiana; and

The heating system is operational. A few air supply grills need to be replaced. A return air grill needs to be replaced to accommodate a lint filter.

FP Door Replacement

The door is installed, but the wrong color hinge and hardware was ordered. The correct colors are being reordered and will be replaced (this should take about 4 weeks.) We asked Synergy to install the door with the incorrect colors to stop the leaks (considering that the colors do not impact the performance of the door.) I will reach out again for an update at the end of this month. Still awaiting the correct colored hinge delivery.

The access control is complete and functional.

Roof:

Red Iron was supposed to be onsite Thursday December 5, 2024, to fix the roof leaks.

Electrical:

Deficiencies are still being examined, and corrective work is ongoing by Gibbs.

Fifth Street Improvements

This project has been awarded by DOTD. DOTD and their consultants will perform construction administration.

25th Street Canal Subbasin Improvements Project.

BKI and DBA are progressing to a 90% submittal for the city to review. We still plan to meet the schedule for advertising early next year, January 2025. We are still awaiting a meeting date to be finalized to go over the project and project costs.

Governor Hall Connector Project.

The property plot survey was submitted to UP Real Estate to determine the amount of Right of Way property needed to build the extension and new railroad crossing. Constant; and acknowledging the state of emergency declared by Jefferson Parish President Cynthia Lee Sheng, in accordance with LA R.S. 29:727; effecting the City of Gretna, authorizing the expenditure of emergency funds related to the Artic Air Mass; and effecting the Emergency Overtime Payroll Policy on Monday, January 20, 2025, at 12:00 Noon. The Declared emergency ended Thursday, January 23, at 4 p.m. for the City of Gretna Team. Ended Friday, January 24, at 7 a.m. for the Gretna Police Department Team; and ended Saturday, January 25, at 10 a.m. for the City of Gretna Water Department Team, due to the standing Boil Water Advisory (Lifted at 10 a.m.). of the Declared Emergency or imminent threat of weather-related disaster.

WHEREAS, the city may find it necessary to utilize employees to protect the health and safety of the citizens of the City of Gretna and improved property of the city or to assist in preparing the city to open after a "Declared Emergency;" and

WHEREAS, the resources of the City of Gretna may also be called upon to assist in protecting the health and safety of the citizens of the Parish of Jefferson and neighboring communities; and

WHEREAS, if an exempt employee (Salaried) is called upon to perform work during the time of the "Declared Emergency," the employee will be paid their regular pay until such time, that full activation of the Gretna's "Emergency Operations Center" (EOC) is called into action. When the EOC is called into action, a premium hourly rate of pay calculated based on one and a half times the derived hourly rate of the salaried professional employee will be paid; and

WHEREAS, if a non-exempt employee (Hourly) is called upon to perform work during the time of the "Declared Emergency," the employee will be paid a premium hourly rate of pay calculated based on one and a half times the hourly rate of pay regardless of the 40-hour work requirement; and

WHEREAS, payment is predicated on the completion and submission of the FEMA required ICS 214 form by every employee. The ICS 214 forms must be submitted daily to the City's Finance Department to assure adequate FEMA reimbursements will be received; and

WHEREAS, duration of the emergency will be that period from the first day the Mayor and Council Declares the Emergency through the day when the City of Gretna determines that all employees must return to work. It is also at the discretion of the Mayor and Chief of Police to pay premium pay for emergency preparation work prior to the Emergency Council Meeting; and

WHEREAS, there are several distinct decisions, which have to be authorized as it relates to the public health, safety, and welfare during this state of emergency; and

Ratify Ord. #5016; Amend Code to Add Sec. 16-158 Homeless

On a motion by **Councilman** _____, the following ordinance was offered:

ORDINANCE NO. 5016-R

An ordinance ratifying emergency Ordinance No. 5016; amending the Gretna Code of Ordinances, Chapter 16. -Criminal Offenses; by adding Section 16-158. -Prohibited camping on public and private property.

WHEREAS, the City of Gretna has an interest in the health, safety and welfare of its citizens; and

WHEREAS, the City of Gretna is desirous of improving economic development and subsequent quality of life for the citizens of Gretna; and

WHEREAS, the City of Gretna has an obligation to provide its citizens with ordinances that clearly describe permitted activities in the city.

- Definitions.

For the purposes of this ordinance, the following definitions shall apply:

- (1) Camping means engaging in any one or more of the following:
 - (a) Erecting or occupying a tent, temporary structure, or vehicle for living accommodation purposes in a public area or on the private property of another;
 - (b) Starting or maintaining a campfire;
 - (c) Sleeping, lying down on, or residing in a public area or on the private property of another overnight; or
 - (d) Storing personal items in any public area or on the private property of another overnight.
- (2) *Campsite* means a place where camping occurs.
- (3) Overnight means between the hours of 10:00 p.m. and 6:00 a.m.
- (4) *Personal items* mean any items that are reasonably recognizable as belonging to a person and having apparent utility or monetary value.
- (5) Private property means any property that is not publicly owned.
- (6) *Public area* means any publicly owned outdoor area that is accessible to and meant for public use including but not limited to streets, sidewalks, rights-of-way, parking lots, banks of waterways, underpasses, bridges, parks, railroads, bus stops, benches, entry ways of buildings, or parking garages.

That the Gretna Code of Ordinances is hereby amended by adding a Section 16-158, which said section reads as follows:

- Prohibited camping.

- (a) It shall be unlawful for any person to camp in a public area.
- (b) It shall be unlawful for any person to camp on the private property of another without the express written consent of the property owner or the owner's agent.
- (c) This section shall not apply to any publicly or privately-owned facility where camping is a specifically authorized activity.

SECTION 3. That the Code of Ordinances is hereby amended by adding a section, to be numbered 16-158, which said section reads as follows:

Section a) - Enforcement.

(a) Upon discovery of a campsite prohibited by this section, the campsite may be removed under the following circumstances:

- (1) A notice to vacate the area within 24 hours shall be posted, which shall include information on available shelters, housing assistance, and human services, and the contact information for public and private entities that offer such services.
- (2) Any items that remain after the expiration of the 24-hour period are subject to removal by the City.
- (3) A 24-hour notice to vacate shall not be required if a law enforcement officer determines that there is an imminent health and safety threat.
 - (b) Any personal items shall be held for a minimum of 30 days for the owner to claim after providing proof of ownership. Items not claimed after a minimum of 30 days are subject to disposal by the City.
 - (c) A copy of every summons issued under this ordinance shall be served on the Jefferson Parish Human Services Authority.
 - (d) Any person who fails to vacate the area within 24 hours following the posting of the notice to vacate the area, or after being ordered to do so by a law enforcement officer who has determined that an imminent health and safety threat exists, shall be punished as follows:
- (1) Upon first conviction, a violator may be sentenced to no more than ten hours of community service.
- (2) Upon a second conviction, a violator may be sentenced to not more than 20 hours of community service.
- (3) Upon third or subsequent conviction, a violator may either be sentenced to not more than 30 hours of community service, punished by a fine not to exceed five hundred dollars (\$500.00), or punished by imprisonment for a term not exceeding six (6) months, within the discretion of the trier of fact.

Provided that a majority of the City of Gretna Council have voted in favor of this ordinance, this ordinance shall have the full force and effect of law immediately following the Clerk's presentment of the same to the mayor, in accordance with Louisiana Revised Statutes 33:406(c)(2).
