1. Call to Order and Roll Call:

Mayor Belinda C. Constant chaired the Council Regular monthly meeting; the City Clerk was present; Mayor Constant called the meeting to order at 5:34 p.m. -The roll was called; a quorum of five Council Members was present; Wayne A. Rau, Councilman at Large; Rudy S, Smith, District 1; Michael A. Hinyub, District 2; Mark K. Miller, District 3; and Randy S. Carr, District 4.

2. Invocation and Pledge of Allegiance

Upon opening of the meeting, Councilman Rau, Councilman at Large offered a prayer. Thereafter, the Pledge of Allegiance was recited.

3. Opening Remarks by the Mayor:

Mayor Constant announced on a city project; for all those watching on Facebook. The City of Gretna on Friday morning (10:00 AM) will be doing a groundbreaking for the **Historic Lighting Project** on Huey P. Long Avenue. To clarify confusion, she explained that fifteen years ago, the city embarked on a project on historic lighting on Huey P. Long Avenue downtown, and fifteen years later this was the final phase of the Historic Lighting Project on Huey P. Long Avenue. It was not a new project.

Fifth Street – There are many questions and telephone calls about Fifth Street due to the mobilized equipment. The respective Council Members Hinyub and Smith were paying close attention to happenings on Fifth Street. The activity on Fifth Street was just to identify utilities; Atmos Energy is out there placing their gas flags on the ground; as well as other utilities to be identified. Mayor Constant assured everyone they will be neighborhood meetings; these meetings will be publicly advertised. There will be signage on Fifth Street for dates and times, for those property owners on Fifth Street or residents in Old Garden Park will have a chance to know what is going on with Fifth Street Redevelopment; which is something the city was excited about.

4. PRESENTATIONS:

Mrs. Madason Priore explained that it was a newer concept that began in 2022, but it was a grade that the Louisiana Department of Health has to hold water treatment plants accountable. It involves the inside of the plant, the disinfection of operators certifications; deals with operation and maintenance to make sure that we are in compliance and adhering to the regulations; and we are happy to have obtained an "A" grade. E. National Flood Insurance Program (NFIP) Community Rating System (CRS) Class Improvement.

Ms. Danika Gorrondona, Gretna Building Official informed the Mayor and Council Members that the Association of State Floodplain Managers of the United States will be in New Orleans for the annual conference. They will be coming to the City of Gretna on Tuesday for a technical tour of all the great work we have done relative to resiliency and green infrastructure. We are a showcase city, and there was excitement about it; and many will be seeing the levees for the first time. Thanked Mayor Constant for affording the opportunity to this group of people that will be visiting Gretna for the very first time.

Community Rating System (CRS)

Ms. Danika Gorrondona explained that the Community Rating System (CRS) for the National Flood Insurance Program (NFIP), a volunteer program; it is on scale from 10 where it start, working your way down, and that would be the percentage off your flood insurance. They are 1,500 communities participating in the CRS, National Flood Insurance Program (NFIP), and the City of Gretna has incredible retained the certification of a 5 scale. The City of Gretna was second in the State of Louisiana to have this rating; and accolades to the City of Gretna, and all the people who participate within the CRS. Thank you for all the support given. This rate means a savings of 25% of flood insurance.

Mayor Constant formally presented to Miss Danika Gorrondona and team, the FEMA Certificate that gives the City a 5 Class rating. "the City of Gretna successfully participates in the National Flood Insurance Program; Community Rating System. This Community has undertaken a serious and meaningful activities to protect its citizens of losses caused by flooding and has significantly achieved the requirements for National Flood Insurance Program participation effective flood plain management".

5. Vested Rights Determination:

A. Reconsideration of the vested right termination for the property at 2224 Newton Street; further described as Lot 113-B1, Vicknair Add. Ernest Richard, Pastor. (Councilman Miller, District 3).

-Mr. W. J. LeBlanc, City Attorney recalled that many months ago, there was a vested right issued to the 2224 Newton Street property for construction of a church, which had several problems (not properly permitted) and work was not done timely; so the vested right determination expired. Several months ago, this matter came before the Council; the Council decided that it would terminate the vested rights associated with this particular project. Following that time, the Pastor Earnest Richard approached the city with counsel to try to reopen the matter. The City of Gretna considered the plea; allowing a re-hearing on the vested rights. There were certain benchmarks that needed to be met given the history the city had with the project; most of them being financial in nature. No licensed contractor could provide a cost estimate of what it was originally. The City then requested a Letter of Credit or some form of Evidence of Proof that Pastor Richard had the financial wherewithal to actually complete the project. There were several meeting had; one meeting with a licensed contractor and Pastor Richard and he in the Mayor's office; in this meeting it was explained that they would need to provide information; and given the lack of resources that prevented them from going forward with licensed contractors initially.

This matter came up again last month, and the Pastor Richard was told he needed to provide the city with the requested additional information; and that the city had ran out of extensions and the Council was ready to move forward with a vote on the rehearing of the determination of the vested rights.

-Mr. W. J. LeBlanc questioned Miss Amelia Pellegrin, Director of Planning and City Development Department if she has received any documentation from Pastor Richard since the last meeting. – Miss Pellegrin replied, no.

-Mr. LeBlanc advised at this point, it would be appropriate for the Council to vote on the rehearing; he believed that a motion to deny the rehearing would bring this portion of the matter to a close; stating the city has bended backwards on this matter for over year in trying to help this project get done.

Pastor Richard pleaded his case before Mayor Constant and City Council to continue with this project; he wanted to have a place to worship; and he had enough stuff in the building to almost finish the project; and said he presented to Miss Pellegrin proof of the money to pay the contractor to do the job.

-Councilman Miller said the city had exhausted all avenues to help in the success of this project; and at this time he motioned to deny on the determination of the vested rights approval.

On a motion by **Councilman Miller** and seconded by **Councilman Hinyub, IT WAS RESOLVED,** to deny reopening of the vested rights re-hearing for the property at 2224 Newton Street (Pastor Earnest Richard); and the same was approved by the following vote:

WHEREAS, PARISH and CITY are authorized to enter into this Cooperative Endeavor Agreement pursuant to LA R.S. 33:1324 which permits any parish, municipality or political subdivision of the state, or any combination thereof, to make agreements between or among themselves for the repair, improvement, and maintenance of roads, drainage, and sewerage; and

WHEREAS, PARISH is authorized by Section 1.01(3), Section 1.01(8), and Section 1.01(9) of the Jefferson Parish Charter to enter into this Agreement for providing and maintaining streets and operating drainage and sanitary sewerage systems; and

WHEREAS, the public purpose of the Project is described as addressing public safety issues regarding sinkholes by Wildwood Road and Timberlane Drive in Gretna; and

WHEREAS, the Gretna Police Department wishes to declare 115 Glock manufactured Model 21 and Glock manufactured Model 21-SF semi-automatic firearms as surplus property; and

WHEREAS, said semi-automatic firearms are described (Exhibit "A") are no longer sufficient as department issued firearms for police officers engaged in active law enforcement due to their age and obsolescence; and have been replaced with newer, more current and more efficient semi-automatic handguns and are no longer needed for public purposes; and

WHEREAS, pursuant to the Louisiana Revised Statutes §§ 33:4712, these weapons may be declared as surplus property by the City Council since they are no longer used by the Gretna Police Department and no longer needed for public purposes; and, may be sold at private sale; and

WHEREAS, each sale of each firearm shall be conducted by a FFL licensed firearms dealer complying with the provisions of Louisiana Revised Statutes §§ 40:1789; and

WHEREAS, the proposed ordinance shall be advertised in the New Orleans Advocate three (3) times within fifteen (15) days, one (1) week apart; and any opposition must be made in writing and filed with the Gretna City Clerk within fifteen (15) days after the first publication; and

WHEREAS, this proposal is recommended to the City Council as necessary and in the best interest of the City of Gretna, Louisiana.

NOW, THEREFORE, BE IT ORDAINED by the City Council, acting as the legislative authority for the City of Gretna that:

The Glock manufactured Models 21 and Model 21-SF semi-automatic firearms are hereby declared to be surplus property by the City Council. 8. Major Site Plan Review:

1. **83 Westbank Expressway; Chick-fil-A Restaurant** - Review for drive through only. Re-application for site plan review of the prior approved site plan.(2023).

Miss Amelia Pellegrin, Director of Planning and City Development Department provide a detailed report on the major site plan review re-application that was approved by the Planning and Zoning Commission in 2023. These major site plan reviews expire after 12-months, so this was a re-application of essentially the same information. Miss Pellegrin summarized the minor changes; which were to the building itself. So, the site plan in all of the information related to that, was identical to the 2023 application.

This request was reviewed by the Planning and Zoning Commission this past Monday, May 12, 2025; the owner's representative was here. The property was posted the property, and sent out certified mail and to date the city had not received any public comments on the project.

Miss Pellegrin summarized that this development have met all of the requirements in the Unified Development Code. In the UDC, required the need to have space on the property for four cars for a drive thru; this particular proposed development has space for 57 vehicles on the property, with three drive-thru lanes. This will be bounded by Hancock, Truxton Streets and the Westbank Expressway with an entrance and exit on each of those streets.

In summary the Planning and Zoning Commission and Staff recommended approval with the following conditions:

- 1. A signed agreement between the City and the applicant (Chick-Fill-A) as to the scope and responsibilities for site improvements in the surrounding public right of ways is executed. (Resolution approved by City Council earlier this evening.
- 2. The applicant (Chick-Fill-A) agrees that a right turn lane on Hancock Street will be explored if needed after opening.

- 3. Building design be revised slightly to meet the 40% transparency on the Westbank Expressway façade; UDC requires 40% transparency (windows, doors, or building materials as otherwise discussed) two to eight feet above first floor elevation for restaurants.
- 4. As defined in the UDC, the applicant shall have twelve months to begin construction from the date of the site plan approval, or a new application will be required. An extension may be requested in writing to the Planning Director, or the project is underway.

There was a detailed traffic impact study completed for this project, which went through review, State Department of Transportation and Development, therefore we were not anticipating traffic issues with the amount of vehicles on this property to fit on this property and the three entrances.

Miss Rebecca Geiger, Representative for Chick-Fill-A in representation of Sherman Strategies, LLC; expressed they were excited to finally get this project underway. The specifics of the project had not changed, just minor modifications to the building; which would be a better looking building.

On a motion by **Councilman Smith** and seconded by **Councilman Hinyub, IT WAS RESOLVED** to approve the Major Site Plan request of the applicant (Chick-Fill-A) with the conditions recommended by the Planning and Zoning Commission and the City Staff; and the same was approved by the following vote:

Entergy Customer Service:

-Mr. D. J. Taylor, Entergy Customer Service Manager.

- Mr. Taylor addressed the Mayor and Council Members and stated that last month Entergy was requested by the City Council for a presentation on Entergy's Resilient Plan. Invitees to this meeting were Abigal Ortolano, Regional Manager, and Michele Bourg, Vice- President of Customer Service for Entergy Louisiana.

Miss Bourg provided an overview of the outages that happened on May 7, 2025. Entergy had an estimate of 27,000 customers without power. Most of those customers were concentrated in the City of Monroe (north Louisiana). The Westbank of Jefferson Parish, there were 7,000 customers without electricity; the City of Gretna had about 2,800 customers with outages (homes and business) about 1/3 of the overall customer count. Entergy mobilized teams from other areas because the damages, were so localized; moved resources from the Eastbank to the Westbank. Entergy found significant damage in the Timberlane area, there were 70 customers, later on in day on May 7th, without electricity due to a tree damaged by the weather that fell onto our facility and that outage carried over through the night into the next morning. There were 30 poles across the Westbank on the ground with about 50 spans of wire; they were hundreds of customers out and transformers, and those get prioritized through the process and the restoration happened accordingly.

-Councilman Hinyub thanked the Entergy-Louisiana crew for coming tonight, it was appreciated. He said he was shocked by the number of outages in Gretna; and questioned the locations or areas of the outages. He informed driving the city for 2-1/2 hours after the rain, mostly on the north side of the Expressway, and there were no Entergy trucks to be seen. He was curious about the areas where the outages happened, there was no damage on the north side of the Expressway; and that was the reason he was shocked by the number of outages. The lack of response by Entergy on the north side of the Expressway. When speaking to Mr. D. J. Taylor, they were outages in Gretna, the Gretna City Hall building was out of electricity. He received calls from the businesses in the area, expressed he was perplexed, if the city had that many outages, where was the response; and it seemed to his constituents, wanted to know. The time from the event to restoration; which he tried explaining the difference of response and restoration. They were four fuses out that controlled City Hall, the restaurants on Huey P. Long Avenue; but it took 7 seven hours to replace the four fuses. He pointed out that Entergy should be cautious, when saying the restoration or the response was going to be midnight; and Entergy customers need to know the truth. He would like to know, when he gets the response, he will call the network, and he would like to know who, is the network. In times of such weather events, they have to be somebody, boots on the ground they have to be someone that I or a resident can look at and get answers to questions.

-Miss Bourg explained that just because you do not see somebody working at your location, does not mean that there were not things happening; because they likely could have been other issues upstream of that where that could not have been apparent to the customer. how Entergy executes restoration; it first looks for the critical customers; and certainly, City Hall was impacted and was first on the list as they were working with the network peers to effect restoration. Other things Entergy considers, is the backbone of the system; so, if you have down wires and poles outside of their substation, which will mean that everybody beyond cannot received electricity until the upstream problems are handled. As the morning hours went on, there were still assessments for damage, as restoration was happening. Entergy appreciates the patience of their customers. As it relates to the network, those are the gals and guys that do the work, and they are the true heroes of the restoration event; and they served the entirety Westbank of Jefferson Parish.

-Councilman Rau said he rode the south side of the city reporting that he did not see that many power outages Gretna, could there have been a possibility that Entergy statistics were from Gretna, LA 70056, and not 70053. – Miss Bourg said the outages entailed 70053, 70054 and 70056 zip code areas. It was difficult for him to believe that the City of Gretna had 40% of the outages.

-Councilman Miller said he received a few phone calls; received call of a broken pole on Elm Street and Creagan Avenue; the rear of Bellevue out; front of Mason Street was out. Councilman Miller believed he was well versed in determining whether or not is something that is feeding off from down line and needs to be repaired or it is mobilized issue. He believed that perception becomes a problem because, the back was a smaller fix, the pole was a bigger fix; and the front had another fix, this becomes confusing to the public when you return and fix this portion of the neighborhood and leave one block away; this causes confusion and frustration to the residents. Entergy could be more informational so that it can be relay and inform when residents have concerns.

- Miss Bourg informed that Entergy also has the online Blue Outage Map, which is detailed information.
- **-Councilman Miller** questioned Mr. Taylor on the pole situation on 34th Street and Cypress Street, because it was of concern and needs to be addressed, what was the update on that situation. **Mr. Taylor** said they will be addressing that situation next week. The network has scheduled the installation of the pole. He is to update Councilman Miller on the details of that pole. Councilman Miller requested he be updated on the date of the repair, so the residents know the area needs to be cleared of any obstruction.
- **Miss Bourg** continued to report that in April of 2024, Entergy-Louisiana was approved to move forward with Phase One of Resiliency Program.

Grid Resilience Program in Jefferson Parish

\$233 million investment to strengthen nearly 200 miles of power lines across the parish.

Overview:

Entergy Louisiana representatives and local officials celebrated the start of Entergy Louisiana's comprehensive grid resilience plan in Jefferson Parish with ribbon cutting ceremony, marking a critical step toward enhancing the electric grid's resilience supporting a stronger Gulf Coast economy.

Key Highlights

<u>Invest in infrastructure:</u> Entergy Louisiana was investing 233 million dollars over five years to strengthen nearly 200 miles of power lines in Jefferson Parish, upgrading approximately 7,400 distribution poles to withstand of up to 140 mph.

<u>Impact on Local Economy:</u> This initiative will support the Gulf Coast's \$2.4 billion dollars seafood industry, as well as other economic growth, including \$262 billion dollars in Gulf Coast energy investments.

<u>Jobs and Partnerships:</u> United Utility Services and Ampirical Solutions have been contracted to complete these essential upgrades.

Grid Resilience Program Details:

Comprehensive Planning: Using a data-driven approach, Entergy-Louisiana evaluated thousands of potential storm scenarios to identify priority projects.

<u>Economic Benefits:</u> The program is expected to avoid \$1.2 billion dollars in future storm restoration costs, improve daily reliability, and reduce post-storm outages for faster recovery.

<u>Scope of Work:</u> Over 2,100 projects will reinforce approximately 69,000 distribution and transmission structures across the state. (Source: Entergy-Louisiana)

Miss Bourg informed that Entergy-Louisiana was celebrating its 100th years birthday by being a proud partner to the communities it serves in the State of Louisiana; and recognizing that they want to be here for another 100th years, or plus to come.

Smoke Detectors; David Crockett Steam Fire Company No. 1.

Mr. Tim Rhoto, Fire Prevention Officer the city with the David Crockett Steam Fire Company No. 1; for the City addressed the Mayor and Council Members informing of the partnership with the Louisiana State Fire Marshal Office; David Crockett Steam Fire Company No. 1, and Councilman Rudy Smith were offering a free smoke detector installation program, which was offered by the state; but were actively working with the program locally; informed they had an estimate of 100 smoke detectors in the office.

Household eligibility: Must live in the 70053, zip code area; Single-Family homes, NO apartments. For more information, please call (504) 263-2122; installation is free of charge.

Councilman Smith said that Tim Rhoto and he have been working for the last couple of months to resurrect the Smoke Detector Program, at the local level. They have been fortunate to have the help of Miss Summer Cook, Tourism, help to put the program together; notices have been sent out and hopefully get some response. It was a good program; installation of the smoke alarms was free; talk to residents about fire safety. Hope to get feedback.



D. Council District Monthly Report.

Councilman Rau – **Councilman at Large** – Councilman Rau congratulated everyone for the good in the handling the May 7, rainstorm; there was five inches of rain, which was impossible for the pumps to handle that amount of water in such short time. He reported high water in various parts of the city; he also questioned the impact of the Blenk property being cleared, and the drainage taken out; and it could be overloading the drains nearby. The city would need to evaluate the causes of the overloading.

Councilman Smith, District 1 – Councilman Smith informed on the ground-breaking of the Burmaster Transfer Station; it would be 90 to 120-days; it would be good for the residents; and was looking forward to.

Councilman Hinyub, District 2 – Council Hinyub congratulated Miss Danika Gorrondona and the CRS team on the Class 5 rating from FEMA; they worked hard at it. It showed that this administration works hard at taking care of the city, which ultimately resulted in direct savings on the flood insurance. The rating was important because it transfers or relates to savings on the flood insurance. It was a labor of love of the Gretna CRS team; thank you Mayor Constant for participating. The May Fest event scheduled for last Saturday, has been rescheduled for this Saturday, May 17, 2025, on Huey P. Long Avenue from 8:30 AM to 3:30 PM.

Councilman Miller, District 3. – Councilman Miller reminded all about the Gretna Observatory, open Monday and Wednesday nights, weather permitting. The Observatory has had good crowds from 25 to plus people visiting per night. Mr. Thomas Alvarado has been doing a fabulous job at the Observatory. Thanked our State Representative Vincent Cox for his assistance and hard work in securing funding for street repairs throughout the district, happening within the next few weeks. Thanked Representative Cox again in helping the city achieve its goals.

Councilman Carr, District 4 – Councilman Carr reported that successful fundraisers were held at Timberlane Golf & Recreation. The Gretna Green Tournament and Les Dudes tournament, both raised money for worthwhile charities. This showed that TGR and Café Hope were back as a venue for the city. -Councilman Carr plans to meet this month with Garden Park residents concerning the recent street flooding to collect information.

Mayor Constant – Mayor Constant invited everyone to come and celebrate our outgoing chief of police Arthur Lawson out Saturday, May 17, 2025, between 4:00 PM to 6:00 PM. There were so many good things to say about Chief Lawson and his 50 years of service; therefore, we need to celebrate his 50 years of service.

-Mayor Constant informed on the First Tee Summer Program at Mel Ott Park; will have two weeks for children to register for the program, please visit www.firsttee.org. The Hometown Heroes Program benefiting the Ladies Auxiliary of the VFW, which are the banners hanging on the historic lights of Huey P. Long Avenue, representing heroes that have served in the service; and family members who have served in many capacities. Call Ms. Dodie Rackley at (504) 343-3661, to sign up for that program.



12. Citizen Addressing the Mayor and City Council:

Mr. Chris Trosclair a Gretna resident addressed the Mayor and City Council addressing issues with their internet and WIFI with AT&T; which have magnified with the May 7th storm. When AT&T finally came out, the technicians spent 12 hours at their house trying to fix the problem. The technician refused to climb any of the poles behind their home, by the railroad, because six of the poles were in bad condition. Nobody seemed to know who was responsible for those poles. The technician laid their line through the ditch behind their house; and was afraid of what would be the outcome with the next rainfall; and also, when grass spraying, cleaning and cutting the grass begins it could be precarious; and just wanted the city to be aware of that line in the ditch. No date was given on the repair of the bad poles or to properly get their line professionally installed; the poles on the right of way behind their property along the ditch; they were also tree issues along that line.

Mr. Trosclair also thanked the Mayor and City Council for the demolition of the building (motel); when will it be completed? -Miss Amelia Pellegrin replied that it could be by the end of July 2025.

- Mayor Constant said that Entergy's collaboration on the Troxclair's situation will be appreciated.

-Miss Bourg informed that approximately 20% of the poles serving infrastructures are owned by other parties and 80% are owned by Entergy-Louisiana. The ownership can be determined by a birthmark or a seal of the poles where you delineate the ownership of the pole. For everyone's knowledge, every pole was not owned by Entergy; which is process Entergy has to work through with other utilities who are attached to their poles or Entergy was attached to their poles; and this does provide some complication, but it does serve the public good. There was a need to get that cable line out of the ditch. – Mayor Constant said Mr. Trosclair should meet with Councilman Carr for the coordination with AT&T and Entergy.

-Councilman Smith questioned who was actually responsible for disconnected and loose and hanging wires. Future discussion on that situation to be had.

-Mayor Constant said that was a discussion to be had with AT&T and other utility companies; sometimes Cox Cable; the city needs to coordinate with them by having them come to a meeting so that they can provide answer to the poles' situation. -Mayor Constant thanked Miss Bourg and appreciated her collaboration for helping the Trosclair Family.

Mr. Sam Schmidt, a Gretna citizen addressed the Mayor and City Council to present or offer solutions to the flooding. Mr. Schmidt directed his attention to Entergy representatives on the neglected poles and the repair of same; streetlights; hanging wires, etc. He pointed out and questioned the drainage in the vicinity of the Westside Shopping Center complex, addressing the canal on Stumpf Blvd., that canal overflows fast, because the water does not drain through the concrete. Mr. Schmidt pointed out various sites that flood in the vicinity of his district; he said his street (Porter Street) never floods, but in the last three or four years, his street has flooded; but the city does not have the funds to redo drainage; he wondered if trucks needed to be scheduled. -Mr. Schmidt questioned Mr. David Boyd on the timeframe and status of the 25th Street canal.

Mayor Constant said that the 25th Street Canal needed to be 100% financed.
